West Bluff Council

The Peoria police department is doing a bodycam trial. They have three cameras, one for each shift. The video is available through the Freedom of Information Act. If, during an incident, a 3rd party requests that the camera be turned off it must be turned off. This does not apply to person being arrested or detained by the police. The program is paid through federal grant.

The West Bluff approved a motion to write a letter to the city in support of due diligence investigation of the acquisition of the Peoria water district by the city, to be delivered to the Mayor and Council.

Snow Removal

This may be a crazy idea, but then it may be so crazy that it just might work.


The City of Peoria requires homeowners to clear the public sidewalk in front of their property when it snows. However, this is rarely (if ever) enforced in residential neighborhoods. That means that many properties don't get shoveled, making the



sidewalks impassable after heavy snowfalls. To make matters worse, since our sidewalks in the Uplands abut the street, they often get buried in heavy, packed down snow from the street when the city plow comes through, making it harder for conscientious homeowners to clear and keep clear.

That got me thinking: What if we hired a service to clear all the public sidewalks of the neighborhood for us? Businesses hire private contractors to clear their parking lots; why not have the URA hire a private contractor to clear our sidewalks? There are many benefits:

- Snow would be removed consistently, making the sidewalk system usable. Currently, after a major snowfall, some parts of the sidewalk are shoveled the full width of the pavement, others just have a small path, and still others aren't cleared at all. Patchwork clearing of sidewalks is effectively the same as no clearing of the sidewalks.
- Pedestrians wouldn't have to walk in the street. The Uplands has many pedestrians: Children/students walking to school or the bus stop, Bradley professors/staff walking to work, residents visiting area businesses, etc. Currently, these people all have to walk in the street (which the city plows) because they can't traverse the sidewalks. This is unsafe.

- Through coordination with the city, sidewalks could be cleared without fear of them getting repacked later by city plows. Right now, residents who shovel in the morning before work have their efforts nullified because the city plows come by later in the morning and bury the sidewalk again. This not only makes more work for the residents, it makes the sidewalks impassable again until they can be re-shoveled.
- Heavy snow would be removed by appropriately-sized equipment. When a particularly heavy snow occurs, and then the street snow is plowed onto the sidewalk, it is often too heavy to lift/remove for the average person. A private contractor would be using a minitractor that has sufficient horsepower to move these mounds without residents breaking

You get the idea. But the big question is, can we afford it? How much would it cost? Is it even feasible? The only way to find out is to get an estimate, which is what I did. First, I decided that there would have to be a threshold before we had a professional service clear the snow. There's no need to bring out heavy equipment for an inch of snow. Then I went searching for a quote for snowfall of two inches or more per snow event.

Campustown and Avanti's use Blunier Builders to clear their parking lots, and they're used by many other businesses in Peoria. Mike Blunier, who will be at our June URA meeting, provided the following quote. This is a "per push" quote, meaning that each time they come out, the following fees would apply, based on how deep the snow is:

- 2-2.9" would be \$500
- 3-5.9" would be \$850
- 6-8.9" would be \$1,150

I don't know about you, but that gave me a bit of sticker shock initially. But then I started thinking about it some more. That would actually be quite affordable if we had sufficient numbers of households in the Uplands paying their annual dues. At \$20 per year per household, with nearly 400 households in our neighborhood, we could have \$8,000 per year if everyone participated. This would be more than enough to cover snow removal for even the worst winter.

Acknowledging that we will probably never have full participation, however, I still think there are ways to accomplish this. One way is to up the threshold from 2" to 3". If we only have the private contractor clear the sidewalks when the snowfall is three or more inches, it wouldn't cost as much since there are fewer snow events that drop that much snow. Another way is to set up a snow removal fund, similar to our beautification fund. More money could be added in years when there's not a lot of snow events so that we can cover those years when we have a lot of snow. It helps average things out over time. And, perhaps by adding this service, more households will see the value of contributing to the URA.
